ANNEXURE-B

SPECIAL TERMS AND CONDITIONS

1. The work shall be completed within ten (10) days from the date of issue of work order.
2. Rates shall be quoted in the Bill of Quantity (BOQ) furnished in figures and in words. If there is any variation between the rates quoted in figures and rates quoted in words, the rates quoted in words shall be considered. Any column left blank in the NIQ will be considered as incomplete tender and the tender will be rejected for which no communication will be made.
3. All the pages of tender documents must be signed with date by the quotationer.
4. The rate should be inclusive of all Taxes & duties, loading, unloading and transportation to IITG campus.
5. Payment will be made only after successful completion of work. 3% of the bill Value will be deducted as Security Deposit and will be released after Twelve months. No interest shall be paid on security deposit. The Vendor shall have to rectify the defects/replace the parts at his own cost, for defects identified during the period of warranty.
6. Six (6) Month's Period of Liability from the Date of Issue of Completion Certificate will be applicable for repaired/replaced parts.
7. Should have running office at Guwahati.
8. Copy of PAN card, GST Registration certificate should be submitted along with the quotation
9. Must have experience of HVAC work at Government organization or PSU or Autonomous/ reputed Institutions. Equipment must be repaired or replaced though authorized genuine service provider only.
10. The owner reserves the right to take inputs regarding performance of a bidder on any similar work (on-going or completed) from a client whether disclosed in the quotation or not. If any such report from the client is found to be unsatisfactory, the quotation is liable to be rejected.
11. The quotation shall be submitted at IPM Section office during office hours only.
12. The contractor shall arrange all the equipment, machineries etc. required for the works for which no extra charges will be paid.
13. Care shall be taken by the contractor to avoid damage to any part of the building or its finishing. He/they shall be responsible for repairing all damages and resorting the same to their original finish at his own cost. He / they shall also remove at his own cost all unwanted wastage and materials arising out of his work from the site.

15. The Institute reserves the right to stop the work or decrease the items if found necessary at any time.

- a) If, at any stage of the tendering process or during the currency of the contract, it is found that the Bidder has submitted any document(s) which is/are forged, false, misleading, or contains misrepresented facts, such Bidder shall be disqualified from the current tender and shall be debarred from participating in any tender of the Institute for a period of not less than three (3) years and up to five (5) years, at the discretion of the Competent Authority
- b) In such cases, the Earnest Money Deposit (EMD) submitted by the Bidder shall be forfeited without any further notice, and if any contract has already been awarded, the same shall be liable to be terminated immediately, with recovery of any dues, damages, or losses incurred by the Institute
- c) The Institute reserves the right to take further legal action, including but not limited to, initiation of criminal proceedings under relevant provisions of law.
