2. Background:

Indian Institute of Technology Guwahati was established in 1994. The campus is on a sprawling 285 hectares plot of land on the north bank of the river Brahmaputra around 20 kms from the heart of the city. The campus area is comprised of hilly and plain terrain covered with multistoried buildings, parks, lakes, sports complex, etc. The Institutes maintains its quality in the field of construction, education, welfare, etc to promote for social growth. For excellent quality works at a justified cost, the institute invites

3. Scope of Work:

The scope of work includes collection & dumping of all floating matter both living & non-living, organic & non organic on the top surface of the water body at the identified locations by means of trash Booms and Trash Skimmers etc as per site requirement.

4. Name of Work: Cleaning of water body near administrative building at IIG campus

5. Eligibility criteria:

- a) The bidder must be registrar with Govt./Semi govt./ Autonomous body in appropriate class and category.
- b) Must have sufficient manpower along with necessary tools to carry out the job as mentioned above
- c) Preference will be given to the bidders having experience of executing similar work as above (Similar work means cleaning of lake, pond etc.)

6. EOI Processing Fee

A non-refundable processing fee of Rs. 1000.00 in the form of a Demand draft or in favour of 'IIT Guwahati' payable at 'Guwahati has to be submitted along with the EOI response. The bidder may also deposit the EoI processing fees through online i.e. Debit Card/ Credit Card/ Net Banking/ NEFT/RTGS, in which case the bidders have to deposit the documents in regards to the payment made along with the EOI Bids. EoI received without or with inadequate EOI processing fees shall be liable to get rejected.

7. Venue & Deadline for submission of proposal

Proposal, in its complete form in all respects as specified in the EOI, must be submitted to IITG, IPM Section at the address specified herein earlier. In exceptional circumstances and at its discretion, IITG may extend the deadline for submission of proposals by issuing an amendment to be made available on the IITG website, in which case all rights and obligations of ITG and the bidders previously subject to the original deadline will thereafter be subject to the deadline as extended.

8. Validity of Offer & Regarding:

(a)This EOI shall remain valid for as per the completion schedule given above

(b)The Institute reserves the right to curtail/ enhance the scope of the work stated above or cancel, if required, without assigning any reason thereof.

(c)The bidder at their own must visit and examine the sites of work and its surroundings and obtain all information that may be necessary for execution of work prior to submitting the bid for actual assessment of the work.

9. Payments:

(a) The payment will be made for the actual work done as per the work order to be issued by the competent authority.

(b) The rate shall be inclusive of cess, tax, royalty, loading, unloading and transportation etc. of all the materials to work site at IITG campus, Guwahati-39.

(c) No payment will be made for the work which is claimed without relevant work order.

(d) The bidder shall arrange all the plants, equipment, machineries etc. required for the works for which no extra charges will be paid.
